ADULT RIDE-ALONG AGREEMENT, WAIVER AND RELEASE

I, _____, have made a voluntary request to ride in a vehicle assigned to the Pacific Grove Police Department ("PGPD" or "Department") and to accompany the Department during performance of its official duties. In consideration of the PGPD's permission for me to ride in a vehicle assigned to the PGPD, I hereby declare and agree as follows:

1. I am over the age of eighteen;
2. I am not a member of the PGPD;
3. I am aware that the work of the PGPD is inherently dangerous and that I may be subjected to the risk of personal injury, death, loss or property damage by accompanying the PGPD during the performance of its official duties;
4. I freely, voluntarily and with such knowledge assume the risk of personal injury, death, loss or property damage which may arise from, or is in any way connected with the use of weapons, law violators, assault, riot, breach of peace, fire, explosion, gas, electrocution, or the escape of radioactive substances while accompanying the PGPD during the performance of its official duties;
5. I release, waive and discharge the City of Pacific Grove ("City"), and its officers, employees, members or agents, and the PGPD and its officers, employees, members or agents, and each of them, from responsibility or liability for any and all loss, claim or action that may arise due to personal injury, death, loss or property damage, which I have, or which may accrue, as a result of riding in any vehicle assigned to the PGPD or while accompanying the Department during the performance of its official duties and resulting from any negligent act or omission on the part of any member of the PGPD;
6. I, my heirs, executors, administrators and assigns agree to defend and indemnify the City, and its officers, employees, members or agents, and the PGPD and its officers, employees, members or agents, and each of them, against any and all manner of actions, suits, debts, claims, demands, or damages or liability or expense, actual or claimed negligent or wrongful act or omission of mine while riding in any vehicle assigned to the PGPD or while accompanying the Department in the performance of its official duties;
7. I agree to abide by all rules and regulations of the PGPD while riding in any vehicle assigned to the PGPD or while accompanying the Department during performance of its official duties; and
8. I will not be under the influence of any alcohol, or other disabling drug or medication during my ride with the PGPD or during any other volunteer activities with the PGPD.
9. I understand that under certain circumstances and conditions, I may not be guaranteed a return trip back to the PGPD.

This Agreement, Waiver and Release ("Agreement") is intended, to the extent permitted by law, to release and discharge in advance the City, its officers, agents and employees, and the PGPD, its officers, agents, members and employees from any and all liability relating to my voluntary ride in a vehicle assigned to the PGPD or while accompanying the Department during the performance of its official duties. This Agreement is signed freely with full knowledge of the risks and dangers incident thereto.
