10.08.030 Permit – Required for certain animals

In any of the following cases, animals may be maintained within the city limits upon first obtaining a permit from the city manager, or his/her designated representative, after a finding that the maintenance thereof will not be a public or private nuisance, nor detrimental to property values or human health or safety:

- (a) Cats and/or dogs in excess of the limits prescribed in PGMC [10.08.020](#);
- (b) Bees and bee swarms in boxes or hives;
- (c) Chickens;
- (d) Where the animal or animals will be used exclusively for educational and/or scientific purposes and that their presence in the city will not be contrary to the purposes of this chapter or offensive to the owners or occupants of any property within the city;
- (e) Where the restrictions and regulations of this chapter impose substantial hardship on the applicant which is singular and peculiar to him or her by reason of the nature of his or her property and his or her proposed use of the animal or animals (as distinguished from the characteristics or propensities of the applicant);
- (f) The animal or animals are to be used for a temporary period of time in connection with a promotion, display or theatrical-type exposition, circus or performance and appropriate safeguards will be employed to protect the public health, safety and welfare.
